Money Matters

It is my pleasure to be a new contributor to *The View*. My hope is to be a resource on money matters for our AAUW members with financial questions. All questions will be kept confidential and names changed to protect your privacy. I have found over time that I hear many of the same questions over and over. So if you have a question, I suspect other members may have the same question. Please send your questions to me.

This month let's start with how to get your Social Security statement. Did you know that most workers no longer receive annual statements from the Social Security Administration? As of 2012, the only workers who will receive the paper statement are workers above 60 who haven't yet begun to claim benefits and 25-year-olds (on a one-time basis).

Even though you may no longer receive this information by mail, you can access it online at the Social Security Administration's portal. In order to create your account, you will need to visit www.ssa.gov/myaccount and create a profile. You'll have to answer a number of security questions, since keeping your information private is very important. After you've created your profile, you can view your earnings record, see your estimated benefits, and create a paper statement.

If you're currently receiving benefits, you can also use the portal to check your benefit and payment information, change your address and phone number, and change your direct deposit options for your benefit payment.

You can also learn more about Social Security by visiting the Resource Center tab at our website, www.oaktreewealth.com and clicking on the Social Security Info hyperlink.

House Passes Bipartisan Senate Version of Violence Against Women Reauthorization Act; President Obama Signs It into Law



On February 28, 2013, the House of Representatives passed the Senate's version of the Violence Against Women Reauthorization Act (VAWA), and on March 7, President Obama signed it into law. This action gives VAWA reauthorization for another five years, with \$659 million provided for various programs targeting domestic violence—and, specific to the Senate version, on college campuses.

From AAUW Public Policy Director Lisa Maatz:

"Today is a great day to be part of an organization whose volunteer Lobby Corps and members across the country have knocked on Congress' door for almost two years urging a VAWA that would protect all victims and improve campus safety. This has been a long, hard battle, and I am thankful for our advocates and partners' efforts in this incredible victory. AAUW fought for this version of VAWA because it will create meaningful change on college campuses, which is essential in light of high-profile cases of rape and sexual assault."

For those of you who made your support of the Senate bill known to your representatives, your actions helped to better equip our nation both to prevent violence and to help its victims. Thank you for being a Two-Minute Activist.

Equal Pay Day Will Have You Seeing Red



Tuesday, April 9 is the national observance of Equal Pay Day. Across the country, people will wear red to symbolize a gender wage gap that puts working women in

the red as compared with the compensation of their male counterparts.

According to statistics released in 2012 by the United States Census Bureau, women are paid on average 77 cents for every dollar a man makes for doing the same job—a gap of 23 cents. I'm sorry to report that San Ramon's working women in the 15th Congressional District are "right on the money" in that regard. Our average pay rate matches the national average of 77 cents to the dollar.

Our statewide average—about 85 cents to the male-earned dollar—is a little better than the national average. But that's hardly a cause for celebration when you consider that, all over California, women and their families are being shortchanged thousands of dollars a year—and hundreds of thousands of dollars over a lifetime.

Gender pay equity is already a rule of law in the USA. The Equal Pay Act of 1963 prohibits "discrimination on account of sex in the payment of wages by employers engaged in commerce or in the production of goods for commerce." And yet, gender-based wage discrimination is still rampant. How do we close the gap?

- We need to keep affirmative action programs in place to make sure education, jobs, and promotion opportunities are open and offered to qualified women.
- Employers must examine and correct their pay practices through equal pay self-audit guidelines from the U.S. Department of Labor. This is especially crucial in the non-union and private sectors, where blocks to pay equity still exist.
- Women must stand up for equal pay and for themselves. Is a prospective employer able to show that male and female employees are paid equally for the same job? A hiring process that seeks diversity through affirmative action, written pay and benefit policies, job descriptions, and evaluation procedures are all good signs. Discuss confirmed or open gender pay inequities with your human resources representative. If discrimination persists, file a complaint with local or state fair employment agencies or with the U.S. Equal Employment Opportunity Commission.
- Close the pay gap through federal legislation such as the pending Paycheck Fairness Act, which makes it illegal for employers to require a non-disclose/non-discussion of compensation clause as condition for employment. Contact your representatives in Congress and voice your support for this recently reintroduced legislation.
- Show your support for gender pay equity by wearing red on Tuesday, April 9 and encouraging others in the workplace to join you.

Proud To Be a Member

Why did you join AAUW? Many women join because AAUW works in coalition with other women's organizations to help raise awareness about issues that affect women and to encourage legislators to outlaw behavior that is cruel or unfair to women.

We checked out the new national website (www.AAUW.org) and found an updated format, including background information about the Violence Against Women Act recently signed into law by President Obama.

Since April is <u>Sexual Assault Awareness Month</u>, here's an example of some of the items on the new, improved AAUW national website to help us prevent sexual violence. [Note the many clickable links below. —Ed.]

- ➤ **Believe and help survivors** if they confide in you. Visit the <u>Rape</u>, <u>Abuse</u>, <u>and Incest National Network</u> (RAINN) website to <u>find information</u> that will <u>help you</u> help the survivor. They also have information to help you—the friends and family of survivors.
- ➤ #TweetAboutIt. The National Sexual Violence Resource Center provides a variety of tools each year for Sexual Assault Awareness Month.
- ➤ Wear jeans on April 25 as part of Denim Day in LA and USA. The day is a visible way to protest against the misconceptions that surround sexual assault. Order their Denim Day Action Kit and raise awareness at your workplace, neighborhood, or community. AAUW staff participated in 2011, and I recently ordered pins for us to wear when we participate again this year.
- Advocate against military sexual assault. Sexual assault in the military is a well-documented problem, and addressing it is one of the AAUW <u>Legal Advocacy</u> <u>Fund</u>'s current priorities.
- > Do something about campus sexual assault. The rates of campus sexual assault are quite high, yet prevention programs or proper channels for handling perpetrators are often inadequate.

AAUW and Students Active for Ending Rape created a Program in a Box with ideas for concrete action that can lead to concrete change. Download the free guide. Apply for a grant for campus programs. On a rolling basis, AAUW members can apply for AAUW's Legal Advocacy Fund Campus Outreach Grants and receive up to \$750 to hold an event about sexual assault on a local campus. This April, AAUW groups in Arkansas, Illinois, and New York are hosting campus events on this topic.

➤ Apply for a grant for academic or community work. AAUW's <u>fellowships and grants</u> offer numerous funding opportunities for members of the public. Some of the current and past awardees have focused their work on sexual violence issues, and you can, too. <u>Read the application</u> information.

Local Scholarship

Great Opportunity to Raise Money for San Ramon AAUW Scholarships!



Every year the Alameda County Fair needs volunteers. If the volunteers are with a non-profit group, such as AAUW, they will get paid \$4 per hour during the day and \$5 per hour in the evening. The dates are Wednesday, June 19 through Sunday, July 7.

If we can get at least 30 volunteers to work four sessions each, we can earn over \$2,000! That's two additional scholarships! I believe shifts are six to eight hours long in the daytime and four hours long in the evening.

Volunteers get free parking and entrance for each day they sign up to do a shift. You could do two shifts in one day! As a senior (age 62 for the fair), I worked two Thursdays because on that day, seniors get into the fair free and I was able to have extra parking and entrance tickets to either use another day or give to a friend.

Volunteers sign up for the shifts and locations they prefer. I (Sally Scholl) will keep track of everyone's shifts via email. Our AAUW branch will be given the money we earned in September. Anyone 16 or over can volunteer. I did this last year with the mission group "She Is Safe." They had 30 volunteers and raised \$1,912.00. They averaged three-plus shifts per person.

You can sign up for as many shifts as you wish. Please keep me advised via e-mail how many shifts you volunteer for and when you have completed a shift.

All volunteers are invited to a kickoff breakfast on Saturday, June 15 from 9:00–11:00 AM. At the breakfast, you will learn more about volunteering and see all the other non-profit groups that benefit. Let's earn scholarship money and have fun at the same time!

AAUW Board Votes To Support Ongoing Cases

The AAUW Board of Directors voted to contribute funds to seven ongoing LAF cases in the following amounts:

- Cioca v. Rumsfeld, Klay v. Panetta, and Hoffman v. Panetta—\$15,000
- LeBlanc v. Trustees of Indiana University— \$6,500
- Jaureguito v. Feather River Community College—\$5,000
- Thein v. Feather River Community College— \$5,000
- Wartluft v. Feather River Community College— \$5,000

Updates on Two Military Cases

In February, the U.S. District Court for the District of Columbia granted the defendants' motion to dismiss *Klay v. Panther*, stating, "As the Supreme Court has made clear: Judges are not given the task of running the Army." This was the same reasoning the court offered in the *Cioca v. Rumsfeld* lawsuit, which essentially classified rape as an occupational hazard. Attorney Susan Burke will appeal the decision.

The U.S. Court of Appeals for the 4th Circuit was to hear oral arguments in *Cioca v. Rumsfeld* at Washington and Lee University School of Law in Lexington, Virginia on Friday, March 22, but the hearing was postponed.

Senate Hearing on Military Sexual Assault

On March 13, the Senate Armed Services Subcommittee on Personnel held a hearing on military sexual assault. Sen. Kristen Gillibrand (D-NY) announced the hearing shortly after being appointed chair of the subcommittee. AAUW submitted a statement and attended. Regulatory Affairs Manager Beth Scott's blog post about the hearing should be posted on the national website sometime in March.

AAUW Discusses Sexual Harassment in Schools During the U.N. Commission on the Status of Women

During the United Nations Commission on the Status of Women in New York City, AAUW held an event on sexual harassment in schools during the parallel events for nonprofit organizations. More than 80 people from around the world, including many students, attended. AAUW Executive Director Linda Hallman opened the session, which was moderated by AAUW board member Kathleen Cha. LAF Program Manager Holly Kearl presented the key findings of the 2011 AAUW report, Crossing the Line: Sexual Harassment at School. The stars of the panel were a high school teacher and three students who shared their views and recommendations.
