Co-Presidents' Pen

It's November and I'm thinking about giving. My very organized mother bequeathed me planning skills, so I get started working on holiday gifts and cards early. In November I also take stock of what I've donated during the year.

Women's causes are especially on my mind. We've had setbacks: the new Texas laws; the pandemic, which knocked 54 million women out of work and burned-out millions more; the Taliban resurgence in Afghanistan. On the other hand, women have gained representation in corporate leadership at all levels. Women in STEM have progressed from 8% in 1970 to 27% in 2019. A record number of women (just over a quarter) serve in the 117th U.S. Congress. Two important AAUW-supported bills were just introduced at the federal level by California legislators—Women's Health Protection Act (H.R.3755) and Title IX: The Patsy Mink and Louise Slaughter Gender Equity in Education Act (GEEA) (H.R.4097).

Women's equality is an effort that will take generations. We AAUW members are doing our part. In the words of the Talmud, "You are not obligated to complete the work, yet neither are you allowed to abandon it." The future looks bright when we think about the contributions that our Tech Trek campers, scholarship recipients, and national Fellows will make in their lifetimes.

If November puts you in a giving frame of mind, please consider these ways to help the AAUW SR Branch mission:

AAUW Branch Fall Fundraising Campaign: You will soon receive a letter and donation flyer from our board. Please read it to find your favorite project and method of donating.

Giving Tuesday, November 30: Remember AAUW on Giving Tuesday. Check to see if you are part of an organization that matches charitable contributions.

Give from Your IRA: For those of you eligible to take a Required Minimum Distribution (RMD) from your IRA, you may be able to avoid ordinary income taxes by giving part to AAUW via a Qualified Charitable Distribution (QCD). QCD's don't increase your Adjusted Gross Income, your taxable income, or anything related to Medicare. Timing and details are critical, so check with your financial advisor or the IRS.

Volunteer Your Time: Our board seeks amazing people with a few spare hours who can help the Tech Trek program. Please see the Tech Trek article in this newsletter for more information. And if you are interested in helping with something creative or outdoors-y, or if you have have office skills to spare, let us know so we can involve you in upcoming projects.

COVID Protocols

Come Together (Yes, it's a Beatles reference!)

We all look forward to being able to meet together again. In that light, your board has outlined some protocols we are putting in place so we can once more gather in person.

For now, all board meetings will continue via Zoom. Some Programs will also be planned for Zoom. Interest groups who plan to meet in person shall follow the rules outlined below.

COVID circumstances and our efforts to keep everyone safe and yet enjoy time together create a *fluid* situation. The following rules are based on the criteria outlined by the Contra Costa Department of Health and AAUW National. As we see the rules and guidelines changing, we plan to change as well.

In-Person Event Protocols

- Vaccination Status: All attendees, whether an event is indoors or outdoors, shall be required to show proof of COVID vaccination—either a paper or a photo of their CDC vaccination card or the Personal Digital COVID-19 Vaccine Record.
- **Tracking:** Event organizers shall keep a log of event attendees, their signatures, and responsibility waivers for each event.
- **Personal responsibility:** Event attendees will be responsible for their own health decisions and practices. Neither AAUW nor event hosts will be insured for COVID-related mishaps.
- Indoor Events: All participants shall be required to wear masks when attending an AAUW San Ramon event indoors except when consuming food or beverages. Event organizers shall accommodate social distancing and good ventilation as much as is feasible.
- **Outdoor Events**: Mask wearing for outdoor events will not be required.
- **Hybrid Events**: Where feasible, event organizers shall make a Zoom option available for those members who cannot or choose not to attend in person.

School Liaison Sub-committee Co-chair (with Cordelia Hwang)

The School Liaison Sub-committee Co-chairs are the bridge between the Branch Tech Trek program and the four San Ramon middle schools. This shared position would require approximately a total of 15 hours during January and February of 2022.

Key responsibilities of the co-chairs are:

- Contact the school principals or other designated contact (e.g. STEM teachers).
- Solicit school participation in 2022 Tech Trek program and request nominations of current 7^{th-} grade girls to attend the summer camp.
- Follow up with schools, as needed, to see that nomination forms have been completed and submitted.

Readers Sub-committee Co-chair (with Stella Hadjimarkos)

The Reading Sub-committee Co-chairs coordinate the reading and scoring of the camper applications. This shared position would require up to a total of 20 hours from mid-February to the latter part of March.

Key responsibilities of the co-chairs are:

- Form a sub-committee of 5 branch members to read and grade camper applications. (Can be drawn from existing list of past readers and new volunteers and can include the sub-committee co-chair.)
- Have readers complete and sign AAUW Tech Trek Code of Conduct Agreement (e.g., antibullying and sexual harassment training). Materials provided by AAUW CA online.
- Distribute camper applications link, scoring guide, and reporting forms electronically to readers.
- Compile scores and—in coordination with Branch Co-coordinators—select candidates to move on to the interview process.

Leadership Fund

Your AAUW Fund donation supports four strategic giving funds: Education and Training, Leadership, Economic Security, and Governance and Sustainability.

This article will focus on the work of the Leadership Fund, which supports the effort to bolster the number of women in top roles across industries by addressing systematic biases and giving women the skills and resources they need to lead.

Recent federal, state, and local elections brought a surge of women leaders into public office. But while that progress is getting widespread attention, the reality is that women still lag far behind men when it comes to leadership roles. They remain significantly underrepresented at the highest rungs of almost every field: corporate, government, nonprofit, education, law, medicine, finance and banking, and the military. In 2020, there were only 36 women leading America's biggest companies—that's only about 7% of all Fortune 500 CEOs.

The problem is not a lack of qualified potential leaders to fill the roles. Women make up more than half of the U.S. workforce and they receive the majority of university degrees at virtually every level. So while qualified women are certainly in the pipeline, there are barriers and biases that keep them from attaining the highest—and most highly-compensated—leadership roles.

The AAUW Leadership Fund helps women achieve their leadership goals by offering the following:

Career Center: AAUW has a Career Center to help women boost their careers and help them master the skills needed to tackle any career challenge with confidence. They offer free online resources, classes, and events all designed to help women take charge of their futures.

Work Smart: AAUW's free salary negotiation training, Work Smart, gives women the skills to discover their worth and to advocate for themselves—whether looking for a new job or asking for the promotion they deserve. **National Conference for Student Leaders**: Each year AAUW invites hundreds of college women from around the country for three days of leadership training, inspiration, and networking at our National Conference for College Women Student Leaders (NCCWSL).

California Legislative Update and Supreme Court Hearings on State Abortion Laws

In addition to the contribution this month from AAUW California Public Policy Committee Co-Chair Kathi Harper, we are sharing an updated post from the Center for Reproductive Rights website regarding the case scheduled to be heard on December 1, 2021 at the U.S. Supreme Court on *Jackson Women's Health Organization v. Dobbs.* Catherine Lewis

Update on the U.S. Supreme Court's Hearing on Reproductive Rights Case from the Center for Reproductive Rights Website

The Center for Reproductive Rights will return to the United States Supreme Court this term to defend the right to abortion, a right recognized in *Roe v. Wade*, the landmark 1973 decision. On May 17, 2021, the Court announced it will hear Mississippi's appeal of a circuit court decision that threw out Mississippi's law banning abortion after 15 weeks of pregnancy in this case.

This is the first time the Court will rule on the constitutionality of a pre-viability abortion ban since *Roe*. The Court's ruling in *Roe* recognized that the decision whether to continue a pregnancy or have an abortion, which impacts a person's body, health, family and future, belongs to the individual, not the government. Nancy Northup, president and CEO of the Center, said in a statement: "Alarm bells are ringing loudly about the threat to reproductive rights. The Supreme Court just agreed to review an abortion ban that unquestionably violates nearly 50 years of Supreme Court precedent and is a test case to overturn *Roe v. Wade*."

Case background: The Center for Reproductive Rights, the law firm Paul, Weiss, Rifkind, Wharton & Garrison LLP, Mississippi civil rights attorney Robert B. McDuff, and the Mississippi Center for Justice brought a challenge in Jackson, Mississippi against a regime of Mississippi laws and regulations that have created unconstitutional barriers to the right to access safe, legal abortion and that violate the Supreme Court's standard in *Whole Woman's Health v. Hellerstedt.* The lawsuit challenges legal restrictions in Mississippi that place burdens on women seeking abortion services, including laws that demean, delay, and misinform women, as well as a series of Targeted Regulations of Abortion Providers (TRAP) laws and regulations.

As Mississippi has enacted this legal regime over the last two-and-a-half decades, all but one of the state's abortion clinics have closed. The lawsuit also includes an emergency challenge filed to block the state's unconstitutional ban on abortion after 15 weeks. In 2019, the Center also filed a challenge to an even more severe abortion ban passed by the Mississippi legislature, which would ban the procedure as early as six (6) weeks.

The restrictions challenged in the lawsuit include:

- TRAP Licensing Scheme: a restrictive clinic licensing system that singles out abortion clinics for a series of unnecessary and unwarranted regulations that far exceed regulations applied to other clinics providing similar and even higher-risk medical care
- 24-hour mandatory delay: a requirement that women delay their abortion 24 hours after receiving statemandated information; Mississippi does not subject any other medical care to this requirement
- Two-trip requirement: a requirement that a woman make two separate trips to and from the clinic before she can obtain an abortion; no other medical care is subject to this requirement in Mississippi
- Physician-only law: a requirement that only physicians provide abortion care, when evidence and experience demonstrate that other medical practitioners can safely provide this care, as they do in several other states
- Telemedicine ban: a ban that applies only to physicians providing abortions that prohibits physicians from the use of telemedicine to provide consultations and treatment recommendations, including dispensing prescription medications, to patients; no other type of telemedicine consultations or treatments are subject to this prohibition in Mississippi
- 15-Week Ban: a prohibition on abortions after 15 weeks that threatens physicians with civil penalties for providing that care
- 6-Week Ban: a law that would make it a crime for doctors to provide an abortion once a heartbeat has been detected—which can happen as early as six weeks of pregnancy

These requirements and restrictions do not make abortion care safer or improve women's health; instead, they are part of a "step-by-step" legislative strategy by antiabortion groups and politicians in state legislatures to eliminate access to legal abortion. Anti-abortion legislators have implemented this strategy across the country, and these laws and regulations have hit lowincome women, rural communities, and communities of color the hardest.

The Center for Reproductive Rights is using the power of the law and the Supreme Court decision in *Whole Woman's Health v. Hellerstedt* to challenge these unconstitutional laws in Mississippi. The landmark ruling reaffirmed a woman's fundamental right to access abortion, and declared that laws whose benefits do not outweigh the burdens they impose on women's access to abortion are unconstitutional. Updates from AAUW California Public Policy Committee by Kathi Harper, Co-Chair Abortion Justice

Although the constitutionally guaranteed right to an abortion has been systematically under attack for decades, it is currently in danger of disappearing altogether. As AAUW National recently noted, "Every person should have the ability to make their own informed decisions regarding their reproductive life. It is beyond time for abortion to be secured legally, funded fully, and equitably available for all who need it, when they need it, without shame or stigma." With the recent refusal of the U.S. Supreme Court to intervene in the onerous Texas case, it is clear that we can no longer count on the courts to protect this critical right. Congress must pass the Women's Health Protection Act. Watch for Action Alerts from National, use them to keep pressure on your representatives, and sign up now for the 2-Minute Activist if you haven't already done so by clicking here https://www.aauw.org/act/two-minute-activist/.

Legislative Updates

Our last five priority bills that were awaiting the Governor's signature have been acted on. Here are the results: SB 62 (requires fair pay, instead of "by the piece" payment, for garment workers) **SIGNED** AB 367 (free menstrual products must be provided in girls/women's bathrooms in schools) **SIGNED** AB 887 (allows domestic violence restraining orders to be filed electronically) **SIGNED** AB 123 (increases paid family leave benefits to 65–75% of regular pay) **VETOED** AB 1074 (requires hotel and janitorial workers who have lost their jobs due the pandemic to be prioritized for hiring as businesses reopen) **VETOED**
