One of the ways the Census 2020 results will affect our community is the need to change neighborhood election districts. Our March 2022 program will focus on the redistricting process and how it impacts local elections. The date is TBD, so please look for more information in the March newsletter. We will hear a presentation by San Ramon City staff on the process, changes to the current borders, and timing of changes.

The process requires public input which can be made via e-mail (*districtelections@sanramon.ca.gov*) or at public City Council meetings. Future public meetings are scheduled for:

Donation Processing Delays

The AAUW National office in Washington DC experienced severe staffing shortages during the year-end period when many donations arrive.

Member donation checks for AAUW FUND received in November and December have not yet been processed as of mid-January. According to Angela Cooper, Senior Manager in the Washington office, they hoped to have the backlog cleared by the end of January. Donations made in 2021 will be credited for 2021.

We ask any member whose check has not yet cleared as of January 31 to please contact us so that we can follow up.

We strongly recommend that anyone considering a donation to AAUW FUND make their donation online at aauw.org by selecting the DONATE button, instead of by check. Be sure to enter your Member ID number to ensure that it is added to your member record and our branch receives credit. Your member number can be found next to your name in the San Ramon Branch directory.

There was also a delay in processing donations to AAUW-CA SPF for Local Scholarships due to a USPS delivery error in Sacramento. These checks should have cleared by now, but please let us know if your check has not cleared and we will research the problem.

- We provide every member the opportunity to vote electronically or by mail.
- The member roster will be requested from AAUW National in early March, so every branch has time to make sure that all e-mail and mailing addresses are correct.
- Each member with a valid e-mail address on file will receive an e-mail message containing a personal invitation to vote that includes a link to the ballot.
- Members who do not have a working e-mail address will be mailed a paper ballot.

California Legislature Update

This month we share an update from Asha Bajaj, Public Policy Chair for the Danville-Alamo-Walnut Creek Branch of AAUW, regarding the status of various bills in the California legislature. We also want to alert our members to upcoming events that may be of great interest.

The housing crisis in California disproportionately affects low income people and women. This legislative year, Governor Gavin Newsom signed into law 31 pieces of legislation designed to combat California's ongoing housing crisis by providing tools to expand housing production, streamline housing permitting, and increase allowable density across the state. Key housing-related bills, which take effect on January 1, 2022 unless otherwise noted, are discussed below.

SB 7, known as the Housing and Jobs Expansion and Extension Act, took immediate effect as an "urgency statute" to address the state's housing crisis through zoning and the California Environmental Quality Act (CEQA) reform. It reenacts AB 900 through 2025 and extends expedited CEQA review for small-scale infill housing projects.

SB 8 extends the term of the Housing Crisis Act of 2019 (SB 330) to January 1, 2030, and allows applicants who submit qualifying preliminary applications for housing developments prior to January 1, 2030 to utilize the protections of the Act through January 1, 2034. SB 8 also clarifies aspects of the existing law.

SB 9 provides for the ministerial approval of certain housing development projects that contain up to two dwelling units (duplexes) on single-family zoned parcels and provides for the ministerial approval of qualifying lot splits that subdivide single-family parcels into two lots if various criteria are met. Taken together, these provisions allow for the development of up to four housing units without further CEQA review, where only one would have been permitted.

SB 10 enables local agencies to adopt ordinances that allow for up to 10 units per qualifying parcel in transit-rich areas or urban infill sites without CEQA review.

SB 290 amends California's Density Bonus Law to clarify specific provisions of the law and offer incentives to certain student housing projects. First, SB 290 explicitly states that the Density Bonus Law applies to both rental and for-sale housing development projects. Second, SB 290 extends the law's allowance of limited parking to low-income developments.

SB 478, the Housing Opportunity Act, prohibits restrictions on floor area ratio (FAR) that effectively ban the construction of apartment buildings. This bill prevents local governments from establishing a FAR of less than 1.0 for projects that are three to seven units or less than 1.25 for projects that are eight to 10 units.

SB 791 creates the California Surplus Land Unit, a technical assistance unit within the Department of Housing and Community Development (HCD), to "facilitate agreements between housing developers and local agencies that seek to dispose of surplus land; provide advice, technical assistance, and consultative and technical service to local agencies with surplus land and developers that seek to develop housing on the surplus land; and collaborate with specified state agencies to assist housing.

AB 571 prohibits local governments from imposing affordable housing impact fees on the affordable units in a housing development's density bonus project.

AB 1398 requires local agencies that fail to adopt legally compliant housing elements to properly rezone within one year. The bill ensures cities and counties are adequately re-zoning to meet their housing needs.

Abortion Rights Access

The Supreme Court declined to block a Texas law that banned terminating pregnancies after six weeks.

Abortion rights advocates counted one win when the federal government announced it would allow patients to receive abortion pills prescribed for up to 10 weeks of pregnancy by mail, although some states will continue to have their own restrictions on mailing the medication.

In the session that began in January, California legislators hope to push forward **Senate Bill 245** by Sen. Lena Gonzalez (D-Long Beach), which would put an end to out-of-pocket costs paid by those seeking abortions that on average range from \$300 for a medication abortion to nearly \$900 for a procedural abortion, according to the California Health Benefits Review Program.

Public Policy, continued

Renewed interest in the bill was sparked by Newsom and legislative leaders, who in September asked Planned Parenthood Affiliates of California and dozens of other supporters to develop a plan for the state to become a sanctuary for anyone denied abortion services in other parts of the country.

The coalition, the California Future of Abortion Council, recommended 45 changes earlier this month to improve access for residents and create additional capacity should states outlaw abortion, including exhorting lawmakers to prioritize SB 245 and get it past the finish line.

OML will send out a Zoom link via IBC and e-mail in advance of the meeting, and the link and any publicity will be forwarded to other AAUW branches including San Ramon. This event will also be open to the public.

March (Date TBD)

The San Ramon Branch is planning a meeting, most likely also via Zoom, with San Ramon City Staff regarding Census Redistricting, how that will affect local residents, and what it means for AAUW issues. As this may happen prior to the IBC March meeting, we will send out more information as it comes in. Again, we hope for a large branch turnout and public participation.
