
The theme for Women's History Month 2024 is "Women Who Advocate for Equity, Diversity, and Inclusion." According to History.com, this theme recognizes women who understand the need to eliminate bias and discrimination from individuals' lives and institutions. DEI, as the trio of values is often abbreviated, is a core tenet of AAUW's strategy. I thought it might be useful to share what these terms mean to the organization.

**Diversity:** "Diversity means variety and is all about what makes us unique." Diversity relates to people's characteristics. There are many dimensions to diversity; for the DEI movement it primarily refers to those aspects such as ethnicity, gender, and religious beliefs that have historically been used to differentiate people. DEI efforts aim to increase diversity—for the benefit of individuals and for the community. In the business world (which is my background), increased diversity is recognized as contributing to more innovation and creativity, better decision-making, faster problem-solving, more error-correcting, as well as a range of social and psychological benefits. All good stuff—don't you agree?

**Inspire Inclusion** 



Equity: "Equity means everyone having equal access to what they need to be successful," says the AAUW website. Equity and equality mean different things, although the terms are often used interchangeably. Equality means everybody gets the same thing. Equity is about leveling the playing field so that everyone's opportunity is equal. Social equity initiatives generally seek to eliminate the effects of systemic inequalities of the past and present so that chances of success become fairer. It's interesting that the Women's History Month theme puts E before D and I. The Center for Creative Leadership asserts that this is the way things should be because without Equity, efforts for Diversity and Inclusion are not sustainable.

Inclusion: Diversity advocate Verna Myers once said, "Diversity is being asked to the party. Inclusion is being asked to dance." Inclusion requires cultural changes that create environments where everyone feels welcome, supported, respected, and valued. We don't get the benefits of diversity if inclusion isn't also part of the equation. What really brings the concept home for me is recalling the times when I wasn't included. There were many times when I was the only woman at the table. In some groups that didn't matter, but in others the vibe in the room was definitely not conducive to dancing!

This year's theme recognizes women who *advocate*. Advocation is public. It's taking even a small, local step toward telling your community what you believe in. As Elie Wiesel said, "Silence helps the tormenter, never the tormented." This month, we can join together and take a moment to speak our values.

A lifelong learner, Laura digs into research and listens to others' perspectives, working to ensure that concerns are discussed, questions are answered, and everyone walks away feeling united.

With a professional background in marketing, communications, and graphic design, Laura graduated from the University of Wisconsin with a degree in art and is currently working in Marketing and Communications at UC Berkeley's Magnes Collection of Jewish Art and Life.

For the last 17 years, Laura has been volunteering and filling leadership roles in public schools. She currently serves as chair of the TRAFFIX Board and as a board liaison for SRVUSD's Equity Steering, Strategic Arts, Parcel Tax Oversight, LCAP Stakeholder, and Special Education Community Advisory Committees.

Laura and her husband, Shawn, are raising four insightful, independent-minded teenagers in the Dougherty Valley after moving them from Martinez, to France, to Delaware, to SoCal, and back to the Bay Area—all grateful to put down roots in the San Ramon Valley, near family and friends.



Our interviewer, Ravneet Julka, is a mother of four children, ages 7 to 18 years old. After graduating from the San Ramon Valley Unified School District, she went on to UC Davis where she first interned for former Lieutenant Governor Gray Davis. Her internship developed into a

permanent job when Mr. Davis was elected governor of California.

After spending a few years in the governor's office in both Sacramento and Washington DC, Ravneet then attended UC Hastings (now known as UC Law) in San Francisco. During her first year in law school, Ravneet married the love of her life and followed him to Georgia—where she then spent nearly 20 years raising her children, working intermittently in local government and in the private legal world, and coaching youth sports.

Since returning home to the San Ramon Valley in 2020, Ravneet has been an active volunteer in PTA, advocating for children's issues at school sites and local school board meetings. She is passionate about ensuring that all children receive a quality education and that all families are welcome and integrated into our community. In her spare time, she works as an attorney, learning new skills every day.

Pat Campbell, longtime member of San Ramon AAUW, passed away at her home in Danville in the loving care of her family on January 28, 2024. Pat was born in Detroit, Michigan and had lived in Danville since 1978. She is survived by her two children, Cari and Chris, and their families and predeceased by her husband, Barry.

Pat began her education in Detroit, graduating from Marygrove College, earning a certificate in Speech and Language Pathology from Wayne State University and a Master's Degree from the University of Michigan. Pat worked as a Speech and Language Therapist in hospitals, clinics, and public schools her entire career—including San Ramon Valley Unified—until she retired in 2001.

In July of 2002, Pat became a member of the San Ramon Branch of AAUW. In addition to her other volunteer and social activities in San Ramon and Danville, Pat became a valued and active member of our branch. Pat participated in the Book Exchange and was part of the Hospitality Committee, but found her "true passion" as a member of the Local Scholarship Committee, serving for over 15 years.

#### The Role of California School Boards

AAUW California is concerned about the censorship of classroom material, the heightened enforcement of board policies rejecting diversity, and providing discriminatory policies against gay and minority students. This concern now leads me, as a former school board member, high school teacher/department chair and adjunct college professor, to reflect on the role of school boards in California and their limitations.

The State Board of Education (SBE) is the controlling structure for K-12 and is the governing and policy-making body of the state for public education. Among its duties is the adoption of statewide academic standards for content and curriculum frameworks. These inform and guide the local school boards in the development and implementation of specific curricula for K-12 students and serve as the basis for the adoption of instructional materials. School board members represent districts within the school district boundaries. As the only locally elected officials representing the interests of school children, board members are advocates for students, the district's educational programs and public education. The California Education Code requires that governing boards of school districts adopt instructional materials in accordance with the state framework adopted by the State Board of Education and district boards shall provide substantial teacher involvement in the selection of instructional materials.

In 2016, the New State Framework in History and Social Sciences was issued and supported the Fair, Accurate, Inclusive and Respectful (FAIR) Act. Part of the requirements indicate that all K-12 students shall receive instruction that "strongly emphasizes student inquiry" and "reflects on the contributions of many diverse groups. In 2019 the California School Boards Association (CSBA) Governance Brief stated that "Effective school boards are equity-driven, making intentional governance decisions that combat institutional discrimination and bias (both explicit and implicit) and eliminate disparities in educational outcomes based on socioeconomic status,

gender, gender identity, gender expression, race, religion, national origin, ethnicity, sexual orientation, disability or family background."

In 2023 AB1078 was passed, which requires the California State Department of Education to assess if school boards are in compliance with state laws requiring public schools to provide diverse and comprehensive education. It requires local school districts with insufficient instructional materials to correct this and authorizes the department to purchase (at district expense) adequate curricula if the district restricts students from learning about important topics like racism, sexism, and gender-based marginalization.

AAUW branch members play a critical role in ensuring all California school boards are governed by board members who will follow AB 1078, and who oppose policies that infringe on the civil rights of LGBTQ+ students. All our members are encouraged to become vigilant observers of their local districts, and to contact your assigned liaison if members are not meeting their obligations under the guidelines outlined above.
