Your Vote Matters!

Take Action and VOTE!

Registered voters in California received their ballots in early October. Please remember to vote—your voice matters! Here are options on getting your ballot to the County Registrar of Voters office:

1. **Complete it and mail it in.** If you do this, mail early. Ballots <u>must be postmarked by November 5</u> and received within 7 days of the election. *OR*

2. Complete the ballot and drop it in an official drop box within Contra Costa County. Locations of San Ramon drop boxes are:

*12501 Alcosta Blvd., by the curved driveway for the Central Park Community Center (enter from Alcosta), *9300 Alcosta Blvd., outside the Alcosta Senior Center, *17011 Bollinger Canyon Rd., outside the Dougherty Station Center/Front Row Theater.

There is <u>no</u> ballot box at San Ramon City Hall. OR

3. Take your completed ballot to a Vote Center (polling place) and hand it in on November 5, Election Day. You don't have to use the VBM ballot. You can vote in person and just hand in your unused ballot at a Vote Center. Be sure to sign the envelope. Signatures are required and verified at the County Election office.

AAUW Supports Measure Q

The AAUW San Ramon Board voted to endorse Measure Q, which renews the expiring \$144 parcel tax currently providing funds to the San Ramon Valley Unified School District. Measure Q funds go to retain teachers and protect STEM and reading arts programs. No Measure Q monies go to administrator salaries or benefits.

Such measures require a 2/3-majority vote, which is difficult to achieve, yet is critical to continue existing programs at the same funding level—so every vote counts! Measure Q aligns with the AAUW Public Policy initiative of providing equal access to quality public education for all students. WHAT: Staff an exhibit from Quest Science Center for 2–3 hours

The Town of Danville and Veterans Memorial Building of the San Ramon Valley will host a Pop-up Museum about space, robotics, science, and the military with lots of exhibits. This is a free, family-friendly event.

Quest Science Center, headquartered in Livermore and serving the Tri-Valley, offers family-friendly STEM events throughout the year. Quest participated at last year's Danville Veterans Day event and was a big hit with its hands-on, interactive exhibits.

Quest Science Center will provide a wind voyager tunnel exhibit. Attendees make parachutes out of coffee filters and test them in the wind tunnel. Two or three volunteers are needed to staff the exhibit in 2- or 3-hour shifts over the 3 days. Shift times are flexible. No STEM experience is needed—come join the fun and learn about wind!

DMV Drops Written Knowledge Test for Some Drivers Over 70

The California Department of Motor Vehicles (DMV) announced that some drivers 70 years old and older without traffic violations on their record in California will no longer be required to take a written knowledge test beginning October 1.

For those renewing their license who are 70 and older, an office visit is still required for a vision exam and an updated photo. The DMV encourages customers to start their application online to minimize the amount of time it takes to complete the process in an office.

First-time drivers and those new to California will still be required to take a knowledge test, as will those renewal customers with poor driving records. See the DMV website at <u>dmv.ca.gov</u> for details.

Public Policy Priorities & the Election

Considering How Groups & Candidates Align with Our PPPs Highlight: Student Loan Debt

At the national and state levels, AAUW has been a leader in the fight for increased economic security for all women, becoming well known for putting out annual data on gender-based wage gaps. However, wage gaps are only one part of the much bigger picture of gender-based economic inequality. AAUW, following contemporary socio-economic research, conceptualizes economic insecurity as part of wealth gaps and debt cycles that are created by multiple factors, including the ballooning cost of higher education.

Education is critically important for social and economic mobility. In 2024, young college graduates still tend to make more money than their counterparts who do not have a college degree, and have higher earnings later in life. However, the value of higher education has become a more complicated calculus for many: as education costs have risen, overall income rates have remained stagnant and low interest borrowing and repayment options to cover these costs have, in many cases, decreased. Without intergenerational wealth, ongoing family support, or scholarship wins, many Americans must go into debt to obtain a higher education. Women are disproportionately impacted by these increasing costs. Women tend to make less money directly after graduation when compared with men. This, combined with additional factors, such as the tendency for women to be burdened with financial and emotional costs of household maintenance, like caregiving, makes any accrued student debt much harder for women to repay. As such, women in the United States owe \$929 billion, or two-thirds of the nation's student debt.

As part of the larger commitment to economic security for women, AAUW has been a leader in pushing for policies that meaningfully address massive increases in the cost of education and the student debt crisis. In California, reducing the cost of education and easing the financial burden of acquiring a degree remains central to AAUW California's Public Policy Priorities, where work to reduce the burden of student debt falls under three of our four Public Policy Priority Pillars.

The issue of student debt, as an issue of women's overall educational access, social mobility, and economic security, also looms large in the current election cycle. Addressing student debt issues in ways that align with AAUW's PPPs may include:

- student debt relief for borrowers;
- making investments in public education;
- expanding federal grant access;
- ensuring the continuation of the Public Service Loan Forgiveness (PSLF) program, which eliminates federal student loan debt after 10 years of work at a non-profit or government agency;
- maintaining Income Driven Repayment (IDR) plans, like SAVE, which take into account unique financial situations and eliminate interest-driven balance increases for borrowers who make ontime monthly payments.

Not addressing student debt issues at all or exacerbating these issues does not align with AAUW's PPPs. Actions taken that are not in alignment may include:

- widespread funding cuts for higher education;
- cutting loan forgiveness programs or slowing their functionality;
- eliminating the Department of Education.

While many candidates have tried to distance themselves from Project 2025, their openly stated and proposed policies may still be in alignment with the 900-page planning document's positions on the topic of women's economic security via higher education access and debt relief: Project 2025 calls for changing, rescinding, or repealing federal student loan forgiveness plans, including PSLF and debt relief through IDR.
